EXAMINATION REQUEST

To be submitted within 7 years of Canadian filing date for applications filed between October 1, 1989 and September 30, 1996; within 5 years for applications filed after October 1, 1996. Must be paid to have prosecution commence.

Small Entity	\$400.	\$260.	\$660.
Large Entity	\$800.	\$260.	\$1060.

We reduce our service charge to \$160.00 if we request examination at the time of filing (or entering the national phase) in Canada). If the request is submitted after filing or national entry and we receive prepayment of the examination fee **and** our service charge we reduce the service charge to \$185.00.

PROSECUTION

Usually involves at least a request for foreign prosecution information. May involve detailed prosecution. Minimum charge about \$200.

FINAL FEE

Payable within 6 months of Notice of Allowance.

We reduce our service charge to \$160.00 if we receive prepayment of the Government Fee **and** our service charge.

MAINTENANCE FEES

Payable on applications filed, and patents issued, after October 1, 1989. First fee is due for payment by second anniversary of filing/issue date. The cost for **each** of the first three payments is:

We reduce our service charge to \$110.00, if we receive prepayment of the Government Fee **and** our service charge. Government fees and service charges are greater for the fourth and subsequent maintenance fees.
